

Just what IS a church council?

The church council is made up of adult members of the church who have been elected by the congregation to guide the church for the year, and make plans for the future.

What does the council DO?

The council is guided by our constitution and is responsible for specific areas of church life -- such as Worship, Education, Evangelism, Property, Stewardship and Youth. The members deliberate make decisions about the policies, practices and plans for the future of our church.

What are the qualifications of a council member?

Congregational Council members are male or female baptized Christians instructed in the Christian faith and committed to being disciples of Jesus Christ. They are men and women of prayer, students of the Bible and active members of their church in good standing, regular in worship, supporting their congregation, willing to give of their time and talent for the mission of the church. They are elected by their fellow church members at the Spring Congregational Meeting. There are normally two positions open each year and the term of each position is three years

What is a council member expected to DO?

Once elected to it specific position on the Congregational Council, they are expected to attend regular and special Congregational Council meetings. The Congregational Council meets once a month, usually the evening of the second Thursday. New council members accept training in the meaning and work of the council.

Each council member is the minister of his or her area of responsibility as described in the by-laws of the constitution. Each minister has a committee of interested and willing members. Once a month the individual committees meet to evaluate, plan and work to carry on and improve their assigned responsibility. Council members plan but are not required to do all the work of carrying out their plans. They are encouraged to seek other church members to serve on committees and task forces assisting in ongoing or special projects. Some committees are directly involved in the work for which they are responsible, such as boards of Fellowship, Properties and Youth. Other boards are indirectly involved in their charge, such as Education, Stewardship or Worship.

The council is responsible for the Spring and Fall annual meetings of the congregation. It is here that church members elect the council members, hear the state of their church, plans for the future, and vote on the proposed programs and budget for the coming year.

Who could or should consider being a candidate for the Congregational Council?

Church members who have a genuine love for Jesus Christ and his church, who are concerned about God's will - the mission and direction of their church, who are willing to speak up and work for the betterment of this community, the family of faith called Springs of Grace Lutheran Church.

The council needs the leadership of members who are willing, not only to give time and money, but are willing, to make, at times, difficult decisions and even risk a little criticism from other members. (It is a fact of life that many church members offer criticism far more frequently than they offer thanks or praise.)

Prospective council members need not have experience in church leadership. (Here is where you get that experience.) There is no sex or age requirement (other than being confirmed and with mature judgment). There is no education, career or financial qualification. Genuine faith and willingness to speak and work is what we need and ask.

Should I consider being a candidate?

The honest answer is - yes, if you are reading this and the above terms seem to fit you. Talk with a member of the Congregational Council or of the Nominating Committee. And.... bless you!
